#### **COVID-19 UPDATE NSW Health**



NSW Health strongly encourages people to wear **face masks** when unable to physically distance, particularly in indoor settings to keep everyone safe. ## **Energy and Water Ombudsman (EWON)**

## COVID-19 Awareness Campaign

EWON's role is to provide dispute resolution services if you are having problems with your energy or water provider. They can provide independent advice about the issue you may have with your provider, they can also arrange for a senior person from your provider to



contact you; investigate the circumstances that led to your complaint or negotiate a settlement between you and your provider.

EWON can also provide advice and support if you are having problems paying your bill.

EWON developed a digital awareness campaign and produced a range of videos and radio ads to help energy customers understand the affordability options available to them during COVID-19. The campaign targets culturally and linguistically diverse communities (CALD) and Aboriginal and Torres Strait Islander (ATSI) customers, seniors and Jobseeker recipients.
